**Terms and Conditions**

Before submitting an entry, please review and agree to the following terms and conditions:

1. In this contest, “images” means any and all images, photographs, depictions or likenesses, either in digital format or otherwise, submitted to the Rural Municipality of Ritchot’s Photo Contest.
  
2. The photographer:
  - grants the Rural Municipality of Ritchot (“Municipality”) the right to store, display, publish, reprint or in any way use all images submitted, in various media formats including but not limited to, print, broadcast and internet, for an unlimited amount of time, without the right of the photographer to inspect or approve the final product, and at no cost to the Municipality;
  - has the written permission of any recognizable persons, and of the parents or guardians of any recognizable minors, depicted in the images granting the Municipality the right to publish their images as provided for in these terms and conditions, and will produce this written permission upon request;
  - will not receive any compensation for any winning images the photographer submits, other than the prizes stipulated by the Municipality;
  - certifies that the images submitted are the photographer’s original work and depict a subject or scenery in the Municipality and that they do not defame or invade the privacy rights of any person and do not violate or infringe any copyright, patent, trademark or intellectual property rights;
  - will retain copyright of the images but waives moral rights to the images so as to permit their use by the Municipality;
  - indemnifies the Municipality, its councillors, employees and agents from liability for any claim that the photographer has misrepresented sole ownership of the images or that the photographer has not obtained the written permission of a recognizable person included in the images.
  
3. The Municipality:
  - has the photographer’s permission to use any and all submitted images for this contest and for any promotional uses the Municipality determines;
  - has the sole discretion to reject images it determines are inappropriate or unacceptable;
  - has the sole discretion to crop, edit or otherwise alter the images, and to select the winning images;
  - accepts no liability in connection with this contest or any information concerning it.
